From the Chairman

Chairman Ashe announced Chair and Vice Chair assignments for the 2018 Standing Committees, as well as appointment of Board Representatives to MARTA's Ethics and Pension Committees.

Overview – Station Naming Policy

An overview was provided of the current policy and MARTA Board member responsibilities. Next steps include forming a cross functional team to review the current policy and make recommendations for needed revisions.

Unsolicited Proposal Policy

MARTA must develop and codify an unsolicited proposal policy. A team will be formed that includes subject matter experts both internal and external.

Trash at Station Concessions

Staff is keeping an eye on cleanliness at those stations that have concessions and vending machines. Littering and graffiti is being monitored.

Passenger Environment Study

Staff will review information from Research & Analysis that is entered into a station-bystation template. Management will address or readdress problem areas – they must be aware of the condition of their station and be accountable.

State Transit Governance Funding

There is a fair amount of discussion taking place around transit governance and funding. Board members were asked to stay in touch with their appointing jurisdictions. This will be one of MARTA's primary focus during the 2018 General Assembly.
